Preamble to the Junior application

Newtec is really focused on building an environment where young keen shooters can enjoy themselves while learning how to shoot (most of them shoot quite well, its scary juniors can do what adults work hard to do without much effort).

Unfortunately, there are some point we must make prior to you completing the application which really won't come as a surprise or be too shocking, but we like you to be informed prior to starting the wheels turning as we aim to get junior applications resolved without too many rigours or delays.

Points:

- Minors cannot own firearms as they are given a permit not a full licence, although it is not prohibited, it can be prohibitive if the parent/guardian is not licenced ABH. We will make every effort to help out if a junior is keen as you can imagine things can be problematic at times as not all members have WWCC certification.
- Parents must be at the range with their child at all times until they have a full firearms licence.
- Minors are 12yrs – 18yrs.
- Guardians must have documentation as proof of guardianship.
 - If the parent is sending the minor with a licenced friend or family, please let us know the details as we have a duty of care to make sure minors are safe.
- The form should be completed and signed off by the parent or guardian as they are of legal age to sign documents.
- Parent or Guardian signs the P650 form on behalf of the minor.
- Identity documents
 - Minor: Birth Certificate / Australian Passport also a Student ID
 - Parent/Guardian: NSW Drivers Licence / Medicare Card
- Changing from the Minors permit to a full licence will require a Firearms Safety Training certificate which can be completed in the months prior to the changeover.
- We strongly recommend that you are across the regulations so that there are no surprises at key checkpoints of the licencing process.

Target shooting is quite challenging and not as susceptible to poor weather as other sports so it is a great supplement to other sports.

If you have any questions please do not hesitate to ask, we will help where we can. The main point on that list is the first point, really consider joining with your child as it makes life easier, but it is also a sport that you can do with your child, there aren't many sports you can enjoy like shooting as a family.
